## 03/02/2018 v4.80.60: Varied Improvements and Bug Fixes

1. Bug fix in Driver Portal - Issue occurred when Driver attempted to Reject a status from a New ELD Log entered by a Manager when no previous Log existed
2. PDF Exports - Stability and performance enhancements
3. Restriction enhancements as required by FMCSA for ELD:
  - a. Carrier Name minimum Length of 4 chars
  - b. Carrier DOT max Length of 9 digits and allow only Numeric
  - c. Driver Logon should have min length of 4
  - d. Driver First and Last name should have min length of 2
  - e. Vehicle VIN must have a digit in the 9th position

Error messages enhanced to include which Driver and License was found to be a duplicate

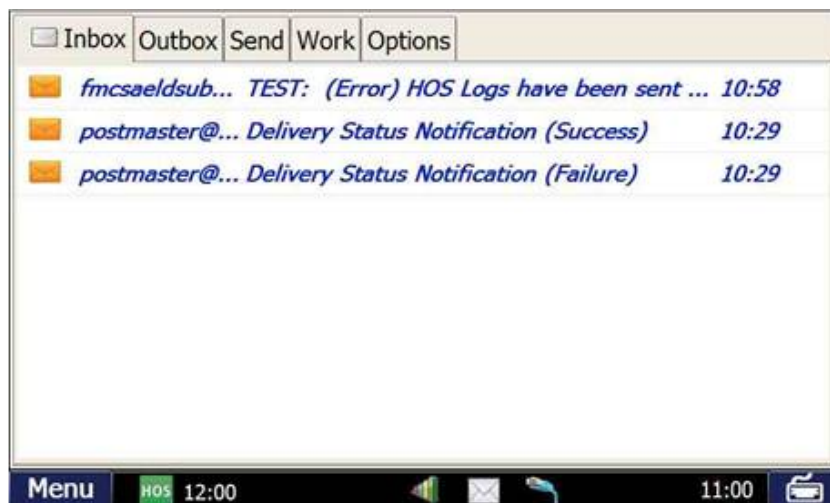
Additional Duplicate detection added and now covers full spectrum of editing: Driver, Terminal, Terminal Authority and Ad-Hoc Authority

## 12/18/2017 v4.80.52: ELD Roadside Enforcement TEST MODE now available

Ability to perform a "test" of ELD Roadside is now supported to facilitate Driver/Company Training. To utilize "Test Mode":

1. On the ELD, perform normal steps to enter Enforcement View
  - a. Tap HOS Icon
  - b. Tap Options Tab
  - c. Tap Enforcement View button and select appropriate option
  - d. Tap "Send Logs To Enforcement"
2. On the Enforcement View screen, Enter "TEST" then any additional comment youd like to provide; The key part is that *the word TEST is at the beginning of the entry*.  
If the word TEST is not found at the beginning of the File Comment then full Enforcement processing will occur

### ELD Roadside Audit support added (Device HOS->Options->Enforcement View)

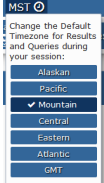
1. ELD roadside will send the Last 8 days of the Logged On Drivers Logs to the FMCSA and
  - a. Send a message back to the Drivers Email address (the DT-xx-xx email address) to notify of submission completion and result (no attachments)
  - b. Send a message to the Managers configured to receive "cc hos email/fax" alerts to notify of submission completion and result (with attachments)
 Note: the email attachments may be discontinued when future UI enhancements are add to the web portal
2. AOBR roadside will behave as it has in the past with the addition of a Success/Fail reply to the Driver

## Various UI enhancements AND ability to Temporarily Change Timezone

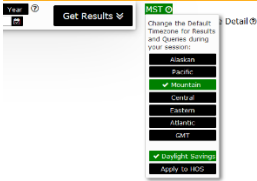
Many UI enhancements have been added to provide a better user experience - we welcome your comments!

DriverTech customers may access this via the Menu Bar:

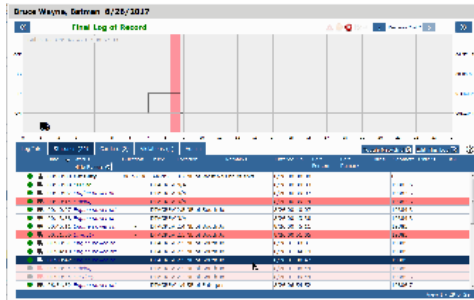
